The Maryland Association of Pupil Personnel takes great pleasure in announcing the annual PUPIL PERSONNEL WORKER OF THE YEAR award. This award will be presented during our MAPP Spring Conference.

NOMINATING CRITERIA:

- 1. The nominee must currently be a Pupil Personnel Worker (PPW), employed full-time within the State of Maryland, and have at 5 years minimal as a PPW.
2. The nominee must be a member of the Maryland Association of Pupil Personnel.
3. Any person, regardless of position or relationship to the nominee, including students, may make the nomination.
4. The nomination form and supporting narrative must be submitted on this form.

The nominee will be judged on the following criteria:

- Original and effective approaches to the delivery of pupil personnel services
• Competence as a pupil personnel worker
• Evidence of continuing interest in professional growth
• Participation in MAPP

Supporting narrative: In three pages or less, explain why you believe your nominee should be selected as Pupil Personnel Worker of the Year. Attention should be given to nominee's contributions to students and families, school, and community as well as any other facts you feel may be relevant to the decision. Up to FOUR letters of support from individuals professionally associated with the nominee may also be included.
